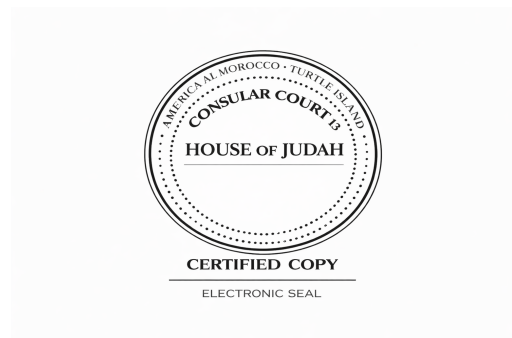

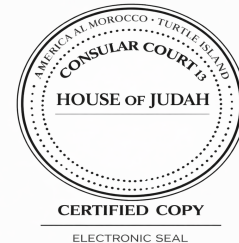


It appears that the Assessor's Parcel Number (A.P.N.) may have been changed multiple times or at least was inconsistent throughout the multiple title changes on multiple documents.
