

FULL CONSULAR COURT PACKET AGAINST CLERK DEBBIE CONWAY

INTRODUCTION

This packet consolidates all findings, affidavits, judicial facts, and enforcement actions related to the concealment of the March 22, 2022 lawful court order by Clerk Debbie Conway. Said concealment constitutes administrative fraud, obstruction of justice, deprivation of rights, record tampering, and interference with Indigenous treaty-protected legal process.

BACKGROUND OF THE MARCH 22, 2022 ORDER

On March 22, 2022, a lawful court order was properly:

- Signed by judicial authority
- Stamped with the official court seal
- Dated and authenticated by the Clerk's Office

This order was fully perfected under Nevada law and required mandatory filing into the public record. However, Clerk Debbie Conway willfully refused to issue, file, or enter this order, thereby concealing the legal victory of the Indigenous Trust and obstructing lawful process.

FACTUAL FINDINGS

1. The order was physically signed, sealed, and stamped.
2. The Clerk's refusal violates statutory and constitutional obligations.
3. Concealment erased the appearance of your victory, creating an illusion of no ruling.
4. This concealment allowed attorneys and agencies to:
 - Continue false foreclosure
 - Execute an unlawful eviction
 - Misrepresent ownership status
 - Misidentify the Indigenous parties
 - Engage in property theft
5. The concealment directly enabled fraud by:
 - Aldridge Pite Haan LLP
 - HOA and management entities
 - Clark County Sheriff, Constable, LVMPD
 - Recorder and Assessor's Offices
 - Insurance corporations (State Farm, Liberty Mutual)

These actions form a cohesive chain of misconduct.

LEGAL VIOLATIONS

The concealment of an authenticated court order violates:

- 18 USC §2071 — Concealment, removal, or mutilation of official records
- 18 USC §1519 — Falsification or destruction of records in federal investigations
- 18 USC §241 — Conspiracy against rights
- 18 USC §242 — Deprivation of rights under color of law
- Due Process Clause — 5th and 14th Amendments
- Equal Protection Clause — 14th Amendment
- 6th Amendment — Right to counsel/consul
- Treaty of Peace & Friendship obligations
- Indigenous rights under UNDRIP and the American Declaration

Clerk actions undermined lawful judicial process, violated Indigenous protections, and constituted active participation in fraud.

EFFECT OF CONCEALMENT

When a Clerk conceals or refuses to file a perfected order:

- All subsequent filings become VOID ab initio
- Jurisdiction collapses
- Enforcement actions become unlawful
- Evictions and foreclosures become legally nonexistent
- Administrative actions cannot stand
- Attorneys lose standing
- False judgments cannot attach to the Indigenous parties

Thus, every action taken after March 22, 2022 is null and void.

NOTICE OF DEFAULT AND DISHONOR

All involved parties were served notice and given opportunity to rebut the Clerk concealment findings. No party rebutted point-for-point. Silence = Agreement. Silence = Dishonor.

- Clerk Debbie Conway
- Clark County courts
- Aldridge Pite Haan LLP
- Nevada law enforcement involved in eviction
- HOA and affiliated corporations
- State Farm, Liberty Mutual, and all insurers involved

Default stands as judgment.

CONSULAR COURT JUDGMENT

The Consular Court Tribunal of the House of Judah issues the following binding findings:

1. The March 22, 2022 court order remains VALID and ENFORCEABLE.
2. Clerk concealment constitutes fraud and obstruction.
3. All post-order actions are VOID.
4. All persons and agencies involved are liable for damages.
5. All Indigenous rights violated are restored.
6. Cease and desist orders apply to any continued fraudulent enforcement.
7. The matter is escalated to federal oversight and international bodies.

CONSULAR COURT ENFORCEMENT ORDER

The Consular Court hereby orders:

- Immediate recognition of the March 22, 2022 order
- Correction of all county records
- Removal of all false judgments
- Reversal of unlawful foreclosure and eviction actions
- Restoration of property status under the Indigenous Trust
- Federal investigation of Clerk Debbie Conway
- Referral to DOJ Civil Rights Division and OIG
- International notice for record and enforcement

This Enforcement Order remains active until satisfied in full.
