

WCSO COURT DIVISION
ADMINISTRATIVE ORDER #18-01:

Effective immediately, **this office WILL NOT provide refunds** to customers for service of legal process, *except* in extenuating circumstances involving WCSO personnel.

YOU MUST:

- **GIVE CORRECT INFORMATION ON THE PROCESS INFORMATION SHEET** (i.e., name, address, apartment #, etc.)
- **IF YOU DECIDE TO CANCEL SERVICE** on the documents you arranged to be served, you must request this in writing along with a copy of your valid government issued photo ID so the attempts may be halted. You must appear in the office in person – no cancellations via phone will be accepted without the written request along with your photo ID.
- **IF YOU HAVE A COURT DATE** you must give the WCSO a minimum of 10 working days to complete service attempts before your court date. If the timeframe is shorter than 10 working days office personnel may decline providing service due to the lack of time required to make attempts.

We are not responsible if a subject is actively evading service or if a business declines to allow an officer to serve an individual at the worksite.

ONCE YOU HAVE ARRANGED FOR SERVICE:

Our WCS Personnel will make three (3) attempts in 30 days to serve the Respondent.

Please allow **10 BUSINESS DAYS*** before you check on the status of service attempts for your documents. **This does not include weekend days.* Once your papers have been served, your proof of service will be returned to you via U.S. Mail, or, when you initially submit papers you may arrange to pick up the Proof of Service.

If you are serving a Notice of Hearing or Motion, you will need to contact the office after 10 business days to check the status of your service request. **We do not mail proofs of service for NOTICES OF HEARING or MOTION DATES** for 3rd Circuit Court. That paperwork is held in this office (Room 1711, Coleman A. Young Municipal Center) for pickup in person on or before the hearing date. You will need to show valid photo ID to retrieve your document. Proofs or Affidavits of Service for other Courts are returned to the Plaintiff via U.S. Mail.

When your original Proof of Service is returned to you, it is your responsibility to forward the paperwork to the correct department unless otherwise requested.
